- 2. Complete and submit to Tarion and the Vendor any and all Statutory Warranty Forms and Performance Audits, and any supporting documentation;
- 3. Complete, submit to Tarion and update any and all Performance Audit Tracking Summaries;
- 4. Request, schedule, cancel and attend meetings with Tarion or the Vendor;
- 5. Request, schedule and cancel conciliations by Tarion;
- 6. Receive correspondence and other documents from Tarion or the Vendor;
- 7. Discuss with Tarion and the Vendor any and all warranty claim items on Statutory Warranty Forms, Performance Audits and Performance Audit Tracking Summaries;
- 8. Apply to Tarion for and obtain a password to access the Corporation's account on Tarion's online portal, MyHome, and access any and all information and documents and use any and all features in the Corporation's MyHome account, including the features listed as items 2. to 6. above; and
- 9. Designate others to access and use the Corporation's MyHome account, or any feature of it, including the features listed as items 2. to 6. above.

Unless and until Tarion receives a replacement Appointment of Designate Form, signed and accompanied by a certified copy of a Resolution of the Board of Directors, Tarion shall deal exclusively with the Designate. The Corporation bears the risk of missed deadlines or other consequences of failing to select and authorize a Designate.
