Licence Appeal Tribunal (LAT) — The Licence Appeal Tribunal is an independent agency established by the Ontario government that			

adjudicates and resolves disputes concerning compensation claims and licensing activities regulated by the provincial government, including those activities of delegated administrative authorities such as Tarion. Individuals who have experience with LAT and who have heard homeowner appeals of Tarion decisions will have knowledge of the *Ontario New Home Warranties Plan Act*, will be familiar with the warranty claims and appeal processes, and may have familiarity with some Tarion processes. **Builder Arbitration Forum (BAF)** – The Builder Arbitration Forum is a process that involves an independent arbitrator that gives builders the opportunity to appeal a Tarion warranty assessment. Arbitrators who preside over BAF cases are not employees of Tarion and they issue binding decisions where builders and Tarion have disputes (usually about whether a decision Tarion has made in support of a homeowner warranty claim is correct or not). Arbitrators who have presided over BAF hearings will have knowledge of the *Ontario New Home Warranties Plan Act*, will be familiar with the warranty claims process, may be familiar with some Tarion processes, and may have some construction-related experience. **Consumer Advisory Council (CAC)** – The Consumer Advisory Council acts as an advisory body to Tarion that provides ongoing advice specifically from a home buyer/owner perspective on existing or proposed policies and any proposed changes impacting new home buyers/owners.
